

Rate Adjustment Approved, Effective April 1

Dear Members,

Over the last couple of years, I have written extensively about the transition currently under way in the electric utility industry. The theme of my message has centered on the rising cost of generating and delivering electric energy in the wholesale market.

Electricity generation has been undergoing a major shift that we have not seen since the 1970s and 1980s. The industry has entered a building cycle for new electric generating plants, which are needed to meet the thirst for electric energy that has steadily increased as the population has grown and new electric devices and conveniences have been added in our homes.

In addition to meeting new load growth, some of these new generating plants are replacing older plants that were constructed in the 1940s and 1950s. Due to new and more stringent environmental regulations, it is sometimes more economical to shut down these plants and build new ones than to install costly emissions controls. When new plants and facilities are constructed, their costs go into the rate base and electric bills go up for all consumers. This has been occurring across the United States over the last few years.

This increase in generation and transmission delivery has increased Randolph EMC's wholesale power cost by 19 percent from 2007 to our budgeted numbers for 2013. Even though I consider this increase significant, it is less than the projected 23 percent increase from a few years ago.

As I've mentioned in previous AWARE columns, your Board of Directors and management team have been working to prepare for this increase and lessen the impact to our members as much as possible. We have taken steps to reduce our internal operating costs, offered members tools

and resources to help manage their energy costs, and implemented new technology that enhances the services we provide.

Randolph EMC has also been deferring revenue to lessen the impact from the annual increases we have been experiencing. This deferral has helped offset—to some extent—the increased cost of wholesale power for that year. Using deferred revenue has also allowed us to delay a retail rate adjustment for two years.

As I reported a few months ago, Randolph EMC engaged an independent consultant (Bellwether Management Solutions), to perform a Cost-of-Service and Rate Study of the rate classes we serve: non-commercial, commercial, industrial and lighting. The purpose of the study is to determine if the revenues we receive are reflective of the cost for providing service to those members. We have a responsibility to members to ensure that each rate class is treated fairly and that no one rate class of members is subsidizing another rate class.

After much deliberation on the report's findings, the Randolph EMC Board of Directors approved a rate adjustment that will be effective on April 1, 2013. The details of this rate change are as follows.

BASIC FACILITIES CHARGE ADJUSTMENT

One major change in the rate adjustment is an increase in the Basic Facilities Charge for noncommercial (residential) members. This component of the bill is included in every utility's rate schedule and is designed to cover the cost of our power delivery system. This includes transmission lines, substations, distribution lines, poles, wire and transformers. Everything it takes just to deliver the energy to your homes and businesses makes up the Basic Facilities. In most cases, utilities collect a portion of the Basic Facilities cost within the energy charge portion of the bill.

The analysis from the Cost-of-Service Study determined that the actual cost for Randolph EMC's non-commercial Basic Facilities is significantly higher—\$57.76— than our current charge of \$15.80 per month. Therefore, after much consideration, the new Basic Facilities Charge will be increased to \$23.00 per month to more fairly reflect the actual cost of providing electric service to those members.

BASE RATE ADJUSTMENT

The base rate component of the members' bill is basically the energy charge. Our last base rate adjustment was in 2007. The base rate adjustment that will go into effect on April 1 will raise REMC's base rate revenue for all classes by 12.59 percent. That does not mean the average residential member will receive a 12.59 percent increase. The change in our Wholesale Power Cost Adjustment (explained in the next section) will negate most of the increase and, in the case of the average residential member, will actually result in a slight decrease. Based on kilowatt-hour (kWh) usage data, the average residential member is defined as a member using about 1,000 kWh per month.

WHOLESALE POWER COST **ADJUSTMENT CREDIT**

In January of 2012, REMC set the Wholesale Power Cost Adjustment charge that is on each member's bill at \$12.50 per 1,000 kWh to prepare for higher wholesale power costs. The good news is that our wholesale power costs are, in fact, lower than we had projected. As a result, Randolph EMC will be removing the \$12.50 per 1,000 kWh charge and applying a WPCA credit to each member's bill in the amount of \$6.00 per 1,000 kWh. We project this credit to stay in place through June 2014. At that time, we expect the credit to go away and the WPCA to be at zero.

THE BOTTOM LINE

Now, let's get to the bottom line and answer the question most of you are asking— "How much will I be paying after the rate adjustment?" To help illustrate the details of this rate adjustment, the following chart compares the old and new rates. To keep it simple, we'll look at a residential account that uses an average of 1,000 kWh per month. This comparison also takes into account both the summer and winter rate schedules.

Comparison of Old vs. New Rates for Residential Member Using 1,000 kWh

	Old Rates	New Rates
Basic Facilities Charge	\$15.80	\$23.00
Monthly Rate	\$0.10	\$0.11
Average kWh Usage	1000	1000
WPCA Charge per 1,000 kWh	\$12.50	(\$6.00)
Monthly Bill Total	\$131.85	\$129.50

*Bill total shown here is for illustration only and does not include taxes or other line-item charges that may appear on bills.

When comparing the change in Basic Facilities Charges, increases in energy charges and the transition from a charge in the WPCA to a credit, you can see that the average member will actually see a decrease on their bill. The key to this decrease is largely because of the \$6.00 WPCA credit. When the credit is removed from the bill in the future, the member will see a slight increase.

I have tried to simplify the specifics of this rate adjustment to show you, as members, how it will impact your monthly bill. The new rate schedules are available on our website at www.RandolphEMC.com or you can always contact one of our offices with questions.

We work for you, our member-owners. Your Board of Directors and employee team strive to keep costs as low as possible and provide you with exceptional service. Implementing a rate adjustment is never an easy thing to do, but I am pleased with all the work that has been accomplished the last few years to lessen the impact to you as much as possible.

BYLAWS Relevant to the Qualifications, Nominations and Elections of Members to the Board of Directors

SECTION 2.04. QUORUM

Attendance in person of one hundred (100) members, or at least one per centum (1%) of the total members of the Cooperative, which ever is smaller, shall be required for the transaction of business at any meeting of the members, provided, however, where statute requires a specific quorum for transacting business on a specific matter, said statue will take precedence over the provisions of this section. If less than a quorum is present at any meeting, a majority of those present in person may adjourn the meeting to another time and date at least twenty (20) days later and to any place within one of the counties named in Section 2.01; PROVIDED, that the Secretary shall notify any absent members of the new time, date and place of such adjourned meeting by delivering notice thereof as provided in Section 2.03. At all meetings of the members, whether a quorum be present or not, the Secretary shall annex to the minutes a list of those who were present in person.

SECTION 3.02. QUALIFICATIONS

The persons named as directors in the Articles of Incorporation of the Cooperative shall compose the board of Directors until the first Annual Meeting or until their successors shall have been elected and shall have qualified. No person shall be eligible to become or remain a director of, or to hold any position of trust, in the Cooperative, who: (a) does not have the legal capacity to enter into a binding contract under the laws of the State of North Carolina; or (b) does not have the mental and physical capacity to exercise the corporate standard for business judgment in discharging his/her duties in a manner to be in the best interests of the Cooperative under the laws of the State of North Carolina; or (c) has not been a member of the Cooperative in the Directorate District for which such person seeks election and has received electric service there as his/her primary residential abode in such person's own name for at least one hundred eighty (180) consecutive days next preceding the date of the election; or (d) has, during the ten (10) years preceding the date of nomination, been a regular employee of the Cooperative or of a competing enterprise; or (e) is in any way employed by or financially interested in a competing enterprise; or (f) is engaged in the business of selling electric energy.

A director or director's company may be allowed to sell materials, supplies, equipment, or vehicles to the Cooperative only if at least three bids are submitted to the Cooperative for any such sale, and only if the director or his/her business has submitted

the lowest bid. Upon establishment of the fact that a nominee for director lacks eligibility under this Section or as may be provided elsewhere in these bylaws, it shall be the duty of the chairman presiding at the meeting at which such nominee would otherwise be voted upon to disqualify such nominee. Upon the establishment of the fact that any person being considered for, or already holding a directorship or other position of trust in the Cooperative, lacks eligibility under this Section, it shall be the duty of the Board of Directors to withhold such position from such person, or to cause such person to be removed therefrom, as the case may be.

Nothing contained in this Section shall, or shall be construed to, affect in any manner whatsoever the validity of any action taken at any meeting of the Board of Directors, unless such action is taken with respect to a matter which is affected by the provisions of this Section and in which one or more of the directors have an interest adverse to that of the Cooperative.

When a membership is held jointly by a husband and wife, either one, but not both may be elected a director; provided, however, that neither one shall be eligible to become or remain a director or to hold a position of trust in the Cooperative unless both shall meet the qualifications hereinabove set forth.

SECTION 3.03. NOMINATIONS

It shall be the duty of the Board of Directors to appoint, not less than sixty (60) days nor more than ninety (90) days before the date of the meeting of the members at which directors are to be elected a district nominating committee for each directorate district in which directors are to be elected. Such district nominating committees shall consist of not less than three (3) nor more than five (5) members who shall be selected from the directorate district from which a director is to be nominated. No officer or member of the Board of Directors or close relative thereof shall be appointed a member of such Committee/ Committees.

The Committees shall prepare and post at the principal office of the Cooperative at least twenty (20) days before the meeting a list of nominations for directors, but any fifteen (15) or more members may make other nominations in writing over their signatures not less than fifteen (15) days prior to the meeting and the Secretary shall post the same at the same place where the list of nominations made by the Committees is posted. The Secretary shall mail with the Notice of the Meeting a statement of the number of directors to be elected and showing separately the nominations made by the

District Nominating Committees and the nominations made by petition if any. The members may at any meeting at which a director or directors shall be removed, as hereinbefore provided, elect a successor or successors thereto without compliance with the foregoing provisions with respect to nominations. Notwithstanding anything in this section contained, failure to comply with any of the provisions of this section shall not affect in any manner whatsoever the validity of any election of directors.

SECTION 3.04. ELECTION & TENURE

At each annual meeting of the members, directors shall be elected by secret written ballot by the members and, from among those members who are natural persons; PROVIDED, that when the number of nominees does not exceed the number of directors to be elected and if there is no objection, secret written balloting may be dispensed with in respect of that particular election and voting may be conducted in any other proper manner. Directors shall, unless the members determine otherwise in advance of the initial balloting, be elected by a plurality vote of the members. Drawing by a lot shall resolve, where necessary, any tie votes.

Directors shall be so nominated and elected that, beginning with the Annual Meeting of the members of 1996, directors from directorate districts 2,4, and 7 shall be elected for three (3) year terms; at the annual meeting of the members of 1997, directors from directorate districts 5,8, and 9 shall be elected for three (3) year terms; and at the annual meeting of the members of 1998, directors from directorate districts 1, 3, and 6 shall be elected for three (3) year terms.

Beginning with the next succeeding Annual Meeting of the members, and at each such meeting thereafter, the same number of directors that corresponds to the number whose terms are expiring shall be elected to serve a term of three (3) consecutive years; PROVIDED, that a year as used in this section shall mean the period beginning with one Annual Meeting of the members and ending at the next; and PROVIDED FURTHER, that notwithstanding the terms for which they are elected, directors shall serve until their successors shall have been elected and qualified.

SECTION 3.05. **DIRECTORATE DISTRICTS**

Directors shall// be so nominated and elected that the board shall be comprised of nine (9) directorate districts. A director of a directorate district must be a resident of, and make his/her primary residential abode, on a premises served by an electrical circuit

provided by the cooperative. All the cooperative's electrical circuits, as identified by circuit numbers on the cooperative's maps and records, shall be divided into nine (9) directorate districts. For the purpose of assuring equitable representation, additional circuit numbers may be added to or deleted from a directorate district. It shall be the duty of the board of directors to make such additions to and deletions from, the various directorate districts no later than April 1st of each year. Such additions and deletions, along with the existing directorate district circuit numbers, will be provided to the members. Each of the nine (9) directorate districts is:


District Nominating Committees, Elections & Credentials Committees Appointed


Pursuant to Section 3.03. of the Bylaws of the Cooperative, the Nominating Committees for Districts 1, 3, and 6, from which Directors will be elected at the Annual Meeting, have been appointed. The members that have been appointed to serve on those respective Nominating Committees will meet at the Asheboro headquarters office of Randolph EMC, located in Asheboro, N.C., at 6:00 p.m. on Monday, April 29, 2013, to nominate a candidate who will run for the Board of Directors from each district. All three District Nominating Committee meetings will be held on the same evening. The Elections and Credentials Committee, pursuant to Section

2.08. of the Bylaws of the Cooperative, will also meet on Monday, April 29, 2013, at 7:00 p.m. at the office of Randolph EMC in Asheboro, N.C. It is the duty of the Elections & Credentials Committee to establish and approve the manner of conducting member registration and voting, to pass upon all questions that may arise with respect to the registration of members, count all ballots cast in any election, rule on the validity of any ballots cast, and to rule upon any other questions, protests or objections affecting the results of the election. North Carolina's electric cooperatives, including Randolph Electric, are accepting applications for Bright Ideas education grants for the 2013-14 school year.

Certified teachers in Randolph, Moore and Montgomery counties are eligible to apply for grants of up to \$2,000. Each year, applications are accepted from teachers in a variety of disciplines including music, art, history, reading, science, career-planning and information technology. Interested educators must have a truly creative project for their classrooms to be considered for the grant.

"Last year, Randolph Electric awarded \$10,000 in Bright Ideas funding directly to local teachers," notes Jill Vanness, Director of Communications at Randolph Electric. "We are committed to the local communities we serve, and we believe there's no better way to contribute than by investing in the education of our youth."

Grant applications will be accepted April 1 through September 20. It could pay to apply early: all teachers who submit their applications by the early-bird deadline of Aug. 16 will be entered into a drawing for a \$500 gift card.
